Thank you for applying for a place for your child at BWI Church of England Primary School.

If you are applying for a place under Criteria 2, 3 or 5 outlined in our Admissions Policy, based on regular participation in your faith, you must complete **Part 1** of this Supplementary Information Form (SIF) and ask your religious leader to complete **Part 2**. If you have not attended your present place of worship for a full two years, please request a second form to obtain a further reference from your previous religious leader.

The relevant Criteria are:

Criterion 2:	Children domiciled with parents, legal guardians or carers, at least one of whom worships at least twice monthly for a minimum of two years, in an Anglican place of worship.
Criterion 3:	Children domiciled with parents, legal guardians or carers, at least one of whom worships at least twice monthly for a minimum of 2 years in a church or chapel of a Christian denomination affiliated nationally to ' Churches Together in England ' or to ' The Evangelical Alliance '.
Criterion 5:	Children of major world faiths whose parents, legal guardians or carers participate in worship regularly in accordance with the commitments of the relevant faith, for a minimum of two years, and desire them to attend this Church of England school because of the school's religious tradition.

Full details of the Criteria can be found in the school's Admissions Policy.

If you are applying for a Reception place, you should also ensure that you have named the school on your Local Authority's Common Application Form (CAF) which should be returned to your Local Authority either on-line or in hard copy by 15th January prior to admission. The SIF should also be returned to the school office by 15th January.

If you are applying for an In-Year admission, please return the SIF to the school office, along with your In-Year Application Form.
